# Strategic Plan of RCHKS 2012-13

#### INTRODUCTION

This year and for the first time, a WE Participate and Matrix Concept is introduced as an element in the planning and organization of all Club's service projects/events.

#### CLUB ADMINISTRATION

Coupled with the WE Participate and Matrix Concept, openness and transparency of the Board will help members better understand the work of the Club. Minutes of Board meetings are circulate to all members through e-mail and among them at weekly meetings.

To speed up the deliberation of service projects in particular those require urgent attention among Board members, it would be done through e-mails of exchange. Apart from speed, all Board members would be informed and consulted as it is difficult to get a full Board meeting owing to individual's business commitment.

#### SUCCESSION

Succession is always a problem in many organizations and in particular in charity organizations and Clubs where members are volunteers.



RCHKS has developed a succession plan in which dedicated members irrespective of their country of origin will be identified and be placed under different areas of service for growth and development before taking up the leadership role.

RCHKS has a **five-year succession plan** in place and hence also facilitates implementation of service projects which straddle for more than a year. Incoming Board of Directors will start work in April for seamless transition.

Members' Development

All new members are asked to join one or two service areas upon induction. Prior to that, different services' directors will proactively approach potential members and brief them of their scopes of service and activities. With that in place, inducted members will have a clear understanding of their commitment with RCHKS and help retention of new members.

Proposers of new members are assigned the role of mentor to help their settling down and embark on the Rotary journey through life.

Irrespective of existing or new members, they will be asked or encouraged to join different service committees and/or to participate in the service projects and to walk their talks as a Rotarian.

#### HUMAN RESOURCES

To be successful in serving the needy of the community, dedicated human resources is required. With the introduction of the **WE Participate and Matrix Concept** this year, all Rotarian, their families, friends and interactors are encourage to join the all service projects

Attracting new members to join under this particular economic climate is difficult though not impossible. Through participation in RCHKS service projects, non members would get a feel of what RCHKS is doing and instill a sense of service among themselves. It is hoped to build up a pool of potential members for the future.

With the support of senior members as mentor, younger generation is being recruited and RCHKS to provide a platform for their serving the community.

#### IMMEDIATE RELIEF

To deal with immediate relief situation, an amount of 20K will be authorized by the Board for the President to allocate as and when necessary to meet immediate relief situations. A Council of Immediate Relief with President-Elect, Vice president, Hone Treasurer, Hon Secretary and Subject Service Director is formed to assist the President in this regard.



#### FINANCIAL RESOURCES

Apart from the traditional fund raising activity under Club 888 of RCHKS, our Club has set up a Breakfast Fund to support provision of breakfast to school kids of families under CSSA. Rotary Clubs of Area 3 have been invited to inject funds into the Breakfast Fund to help.

Similar "Fund" concept will be used to raise funds for worthy service projects

Apart from prudence in funds allocation to each area of services, business model of low cost high yield is applied to maximize the benefits and cost effectiveness of donation received.

Collaboration within the  $\mathsf{C}\mathsf{l}\mathsf{u}\mathsf{b}$ 

Under the **WE Participate and Matrix Concept**, there is a mix and collaboration between different service directors and committees for synergy. Interactors will join local service projects whereas when designing service projects, participation of interactors is taken into account. There is also a mix of Membership, Public Relations and Club Administration and service projects.

To promote friendship and uphold the Rotary motto "Service Above Self" (i.e. to collaborate with Clubs within and outside Area 3 on joint project), RCHKS and RCHKNW, RC of Shouson Hill and RCHKIE have joint-hand in setting up a Breakfast Fund to help the needy students.

## **Our Service Objectives**

- To serve the local community in the areas of elderly and education;
- To serve beyond just writing of cheques; and
- To concentrate on maximising positive impact with minimum financial resources by leveraging our Rotarian network including our families, business contacts, and other Rotary clubs.

#### Service Projects in Progress

i) Poverty Relief

- Connected Aplichau Kaifong Primary School with Foodlink Foundation to provide breakfast for 100 school children twice a week. Seeking Tsui Wah Restaurant to consider providing breakfast at cost is in progress.
- Procured IT equipment for Aplichau Kaifong Primary School from Crossroads and the Bank of East Asia in August.
- Established a Breakfast Fund to help needy students. A maximum amount of \$70,000 has been seeded by RCHKS.



#### ii) Elderly Care

- To visit the elders at Yee On Care Centre in Wong Chuk Hang on 28th September 2012.
- To visit in December together with the Haven of Hope Christian Service to the lonely elders

#### iii) Health Care

• Rtn Naresh is volunteering yoga classes to the critically ill at St James' Settlement.

#### iv) Education

• Bookmarks will be produced for primary students to promote politeness and being considerate in public transports (i.e. to give seats to needy)

#### DIVISION OF LABOUR

- All potential projects are first reviewed by all committee members through the use of IPP Martin's objective Assessment Form.
- Rtn Michael WAN, Director of Local Service will both initiate new and coordinate all local service projects.
- PP Paul YOUNG & PP George LI are advisers to the committee.
- VP Betty and Rtn Al PINDEA are going to organise RCHKS volunteers for the Haven of Hope annual visit.
- Rtn Michael WAN & Rtn Al PINEDA will work closely with AKFPS in 2012-13.
- Rtn Stephen Rocke, Rtn Chris, Rtn Dirk will be looking for new projects, while Rtn Naresh is our yoga instructor for the elderly and ill in Wan Chai and Aberdeen.

## International Service

#### Objectives

The International Services team fosters RCHKS's international understanding, cooperation and friendship through:

- Personal visits to sister clubs
- Cooperation in meaningful projects
- Develop and evaluate projects for their matching grant potential
- Connect members of clubs on a personal and professional levels

It is our aim to learn from best practices of sister clubs as well as to share our experiences in how to assess projects in terms of sustainability and impact. To ascertain this we do continue to provide immediate and uncomplicated support for Immediate Disaster Relief while mutually implementing and improving assessment tools and evaluation procedures for projects that the clubs consider to develop or support.



Round-the-World Ambassadors are appointed to promote goodwill and friendship with overseas Rotary Clubs with also a view for matching grant projects in the future.
